**\*Please note: Fees are from 1<sup>st</sup> July 2009 to June 30<sup>th</sup> 2010 only.** WAMASC and Boomerangs fees are at a pro-rata reduced rate per month. AWA & MAAA Fees after December 31<sup>st</sup> are at half rate to new members or ex-members who are re-joining after a break of over 12 months. Joining fee still applies.

**All Memberships terminate on June 30<sup>th</sup> every year. There is no concession.**

WAMASC family membership provides for 2 Parents (or Partners or Guardians) and 2 Junior's of the same family. Boomerangs family membership is for 1 Senior and 2 Junior's. There is no family discount for AWA & MAAA, fees apply for each person. Membership status cannot be varied throughout the year. A junior in the 2009/2010 membership year is anyone born on or after July 1st 1991.
